About Host

全国港澳研究会

全国港澳研究会是由国务院港澳事务办公室主管的全国性民间学术社团。2013年12月6日在北京成立。以整合力量，加强对“一国两制”理论与实践重要问题的研究、加强港澳与内地相关领域学术交流合作为宗旨，发挥民间智库功能。国务院港澳办港澳研究所为研究会的发起单位。

研究会现有33家研究机构为团体会员，个人会员666名。会长徐泽曾担任国务院港澳事务办公室副主任、党组副书记。

研究会成立后，积极推动、引导内地及港澳相关研究机构和专家学者对“一国两制”重要问题开展研究。重要成果及时上报中央有关工作部门，为有关方面决策建言献策。主动就热点问题发表意见，引导港澳社会正确理解“一国两制”方针。同时，以专业、理性、客观的精神与港澳学术界、专业界展开沟通合作，共同推进两地学术交流与发展。

The Chinese Association of Hong Kong & Macao Studies

The Chinese Association of Hong Kong & Macao Studies is a national non-governmental academic society supervised by Hong Kong and Macao Affairs Office of the State Council. Founded on December 6th, 2013 in Beijing, the association is dedicated to combining efforts to enhance research on theoretical and empirical questions of One Country Two Systems. The association also functions as a non-governmental think tank and focuses on promoting cooperation in various domains among Hong Kong, Macao and the mainland. The Hong Kong and Macao Research Institute, a branch of Hong Kong and Macao Affairs Office of the State Council, serves as the sponsor of the association.

As of now, the association has 33 research institutes as group members and 666 individual members. Mr. Xu Ze, who was once deputy director of Hong Kong and Macao Affairs Office of the State Council and deputy secretary of the party committee, now works as Chairman of the association.

Upon establishment, the association has been actively pushing forward the research on important issues of One Country Two Systems. These research findings are then reported to relevant central departments and put to use for decision making. Moreover, the association takes initiative to comment on heated issues and leads the Hong Kong and Macao societies to properly comprehend the One Country Two Systems policies. In the meantime, the association works with academic and professional circles in Hong Kong and Macao to bolster communication and cooperation in a professional, rational and objective way.

深圳大学港澳基本法研究中心

港澳基本法研究中心2009年7月11日揭牌成立，是全国最早独立设置的专门从事港澳基本法研究的科研实体机构，直属深圳大学。中心的成立和建设受到国家相关部门的重视，全国人大常委会港澳基本法委员会和广东省港澳办的领导同志多次莅临检查指导工作。

中心现任主任是邹平学教授。中心现有13人，其中教授5人、副研究员1人、助理教授4人、行政人员3人。

中心围绕服务国家发展战略和港澳工作大局，开展科学研究和咨政服务，发挥对外学术交流平台作用，力争建设成为港澳基本法理论和实践研究基地、人才培养基地、资料信息基地、学术交流基地和决策机关的智库。成立十一年来，中心在学术研究、咨政服务、资料信息、交流平台、人才培养等多方面多有建树，得到中央、广东省、深圳市港澳工作机构的重视和肯定，得到全国港澳研究领域同行专家的好评，形成了良好的学术影响力和社会显示度。

Center for Basic Laws of Hong Kong and Macao Special Administrative Regions, Shenzhen University

The Center for Basic Laws of Hong Kong and Macao Special Administrative Regions was established in July 11th 2009. It is the first research entity specialised in Basic Laws of Hong Kong and Macao. The Center is under Shenzhen University's direct management. The Center has received generous support from a number of State and local government entities since its establishment and throughout its development. Cadres in leadership positions from the Committee of Hong Kong and Macao Basic Law of the People's National Congress and the Guangdong Office of Hong Kong and Macao Work have paid multiple supervisory visits.

The Center now chairs by Professor Zou Pingxue. It is currently composed of 13 staff, including 5 professors, 1 deputy-researchers, 4 associate professors and 3 administrative staffs.

The Center's task closely revolves around the nation's development strategy and the grand plan of Hong Kong and Macao work. It initiates academic research and policy advisory services; performs as a platform for academic networking, and endeavours to become the bases of Basic Law theoretical and implementation studies, talent education, archive and academic networking. It also aims at functioning as the think tank for decision making bodies. The Center has made significant contributions in academic research, policy consultation, data gathering, academic networking and talent education. Its achievements have received affirmative feedbacks from Hong Kong and Macao work related agencies from the State, Guangdong and Shenzhen governments. It has also built up a positive image among academic peers nationwide, and has established constructive academic and social influences.

The same body appointed him as Member of the Preparatory Committee for the HKSAR in 1996-1997. In 2002-2012 Professor Lau was Head of the Central Policy Unit of the Hong Kong SAR Government. Professor Lau has been Member of the Chinese People's Political Consultative Conference since 2003 and Vice-President of the Chinese Association of Hong Kong & Macao Studies since 2013. Professor Lau's research interests include social and political development, society and politics in Hong Kong and international politics. His publications include Society and Politics in Hong Kong (1982), The Ethos of the Hong Kong Chinese (with Kuan Hsin-chi) (1988), Hong Kong Politics in the Transitional Period (in Chinese)(1996), Governance and New Regime Building in Hong Kong Fifteen Years Since the Handover (in Chinese)(2012), Hong Kong's Unique Path of Democratic Development (in Chinese)(2014), The Implementation of One Country Two Systems in Hong Kong (in Chinese)(2015), The Practice of “One Country, Two Systems” Policy in Hong Kong (2017), The Unique Political Patterns of Hong Kong After the Handover (in Chinese) (2017), Thinking About the Future of Hong Kong's One Country Two Systems (in Chinese)(2020), as well as articles in local, Mainland and international scholarly journals.

Wang Zhenmin

Director of the Institute for State Governance at Tsinghua University, Professor of Constitutional Law

Mr. Wang Zhenmin is a constitutional law professor in the Law School of Tsinghua University, and Director of the Institute for State Governance at Tsinghua University and Director of Tsinghua's Center for Hong Kong and Macao Studies. Professor Wang received his LL.B. (1989) from Zhengzhou University in Henan Province, LL.M. (1992) and Ph.D. in law (1996) from Renmin (People's) University of China. He also studied in the Law Faculty of Hong Kong University from 1993 to 1995. He was a Fulbright Visiting Scholar at Harvard Law School in 2000-2001. Professor Wang joined Tsinghua University in 1995 as one of the founders of the new law faculty. After 12 years as Assistant Dean and Vice Dean, he served as Dean of Tsinghua University School of Law from 2008 to 2016. From 2015 to 2018, he was Head of the Law Department of the Liaison Office of the Chinese Central People's Government in the Hong Kong Special Administrative Region. Professor Wang is founding President of China Research Association for Hong Kong and Macao Basic Laws, and founding President of China Research Association for Judicial Cases.



安东尼·卡蒂

安东尼·卡蒂先生现为北京理工大学法学院教授。安东尼·卡蒂曾就读于皇后大学、伦敦大学和剑桥大学，获得国际法史专业的法学学士、法学硕士和法学博士学位；随后在巴黎第二大学和德国海德堡的马克斯·普朗克国际公法研究所从事博士后教学和研究。他先后在爱丁堡大学、格拉斯哥大学、德比大学、威斯敏斯特大学、阿伯丁大学、香港大学和清华大学担任国际法助理教授、副教授和教授，于2017年加入北京理工大学。另外还曾在巴黎第一大学、巴黎第二大学、柏林自由大学、马德里自治大学和东京大学担任客座教授。卡蒂对国际法的跨学科研究特别感兴趣，包括国际法的历史背景、哲学基础和不同文化场景等角度。他在《国际法的衰落》一书中对西方国际法的基础提出批判，并对国际事务中法律想象界限进行了重新评估。此后，他的著作《国际法哲学》第一版和第二版由爱丁堡大学出版社分别于2007年和2017年出版。在香港期间，他从事东亚特别是中国文化的研究，并与简·尼基曼共同编辑了《统治者的道德和责任：作为世界秩序的正义法治原则在欧洲和中国的起源》，该著作已于2018年由牛津大学出版社出版。书中审视了19世纪多国对中国滥用国际法的案例，并提出要用儒道思想反思西方国际法概念基础。卡蒂还发表了许多与中国和东亚有关的报告和文章，其中两项关于中国对西沙群岛和南沙群岛主权的历史研究于2019年在《国际法史杂志》上发表。最近，卡蒂在邹克渊主编的《一带一路倡议和海洋法》（博睿出版社国际法研究，2020年）中发表了《中国的困境：从南海到一带一路》。卡蒂还就一些国际法的一般性问题有所著述，并且是《牛津国际法参考书目》的总主编。近期，他的文章被收录在《2019英国国际年鉴》和《美国国际法杂志》在线版。



Anthony Carty

Professor, School of Law, Beijing Institute of Technology

Anthony Carty is the Professor, School of Law, Beijing Institute of Technology. He attended Queen's University, University College London and the University of Cambridge, obtaining an LLB, LLM and PhD in the history of International Law. He then undertook postdoctoral teaching and research in the University of Paris II and the Max Planck Institute of Public International Law in Heidelberg. He went on to occupy positions of assistant, associate and full professor of international law in the Universities of Edinburgh, Glasgow, Derby, Westminster, Aberdeen, Hong Kong and Tsinghua University, before coming to Beijing Institute of Technology in 2017. He was at various times a Visiting Professor at the universities of Paris I and II, the Free University of Berlin, the Autonomous University of Madrid and the University of Tokyo. Carty is especially interested in the more interdisciplinary approach to international law, having regard to its historical context and philosophical foundations and also to different world cultures. He is especially critical of Western foundations of International Law in his book *The decay of international law, a reappraisal of the limits of legal imagination in international affairs*. He has followed this work up with two editions of *The Philosophy of International Law* published by Edinburgh University Press in 2007 and 2017. From his time in Hong Kong he engaged with East Asian and especially Chinese culture and jointly edited with a Janne Nijman, *Morality and Responsibility of Rulers, European and Chinese Origins of a Rule of Law as Justice for World Order* published by Oxford University Press in 2018. This work considers both the abuses of international law against China in the 19th Century and the need to rethink conceptual foundations of Western international law in the light of Confucian and Daoist thought. Carty has also published a number of reports and articles relevant to China and East Asia. These include two historical studies of the Chinese sovereignty of the Paracels and Spratly Islands, published in *JUS GENTIUM, Journal of International Legal History* in 2019. Most recently Carty has just published *China's Dilemma, Between the South China Sea and One Belt One Road*, in Zou Keyuan editor, *The Belt and Road Initiative and the Law of the Sea*, Brill Nijhoff, 2020. Carty also publishes on a general range of international law issues and is founding editor in chief of the *Oxford Bibliography of International Law*. He has recently published articles in the *British Yearbook of International Law* in 2019 and in the *American Journal of International Law*, Unbound in 2018.

Senior Research Fellow at its Royal Institute for European Studies, where he coordinates a Master in European Union and its related PhD Program in European Studies. He has been Fulbright Visiting Scholar at Harvard Law School (2017-2018) and also a Jean Monnet Professor, appointed by the European Commission. He has published extensively in the area of European integration (a textbook, more than 20 other books, and more than 60 articles in legal journals and book chapters). His main field of specialization is the Single European Market, EU Competition Law and Market Regulation. He is currently leading a Jean Monnet Network on EU-China Relations in the field of trade, climate change, competition and market regulation. He holds a Law Degree from Salamanca University, and an LLM with honors in EU Law from the College of Europe (Bruges). He was a PhD researcher at the European University Institute (Florence, Italy) for 2 years and is a Doctor in law with honors (European Doctorate) from CEU San Pablo University.

He graduated from Peking University with a master's degree in law in 1982. His major interests of research include international law, Law of International Organizations, modern history of China diplomacy, Basic Law of Hong Kong and Macao, as well as the laws related to Taiwan. His main academic achievements comprise lots of books with a focus onto “international law”, “law of international organizations”, “international organizations in the process of the globalization”, “an overview of international organizations”, as well as “development of international organizations and international law enforcement mechanism”. He’s a chief editor for over 20 books of essays on the researches on Hong Kong and Macao, and has published more than 100 papers on Hong Kong and Macao.

Swaran Singh

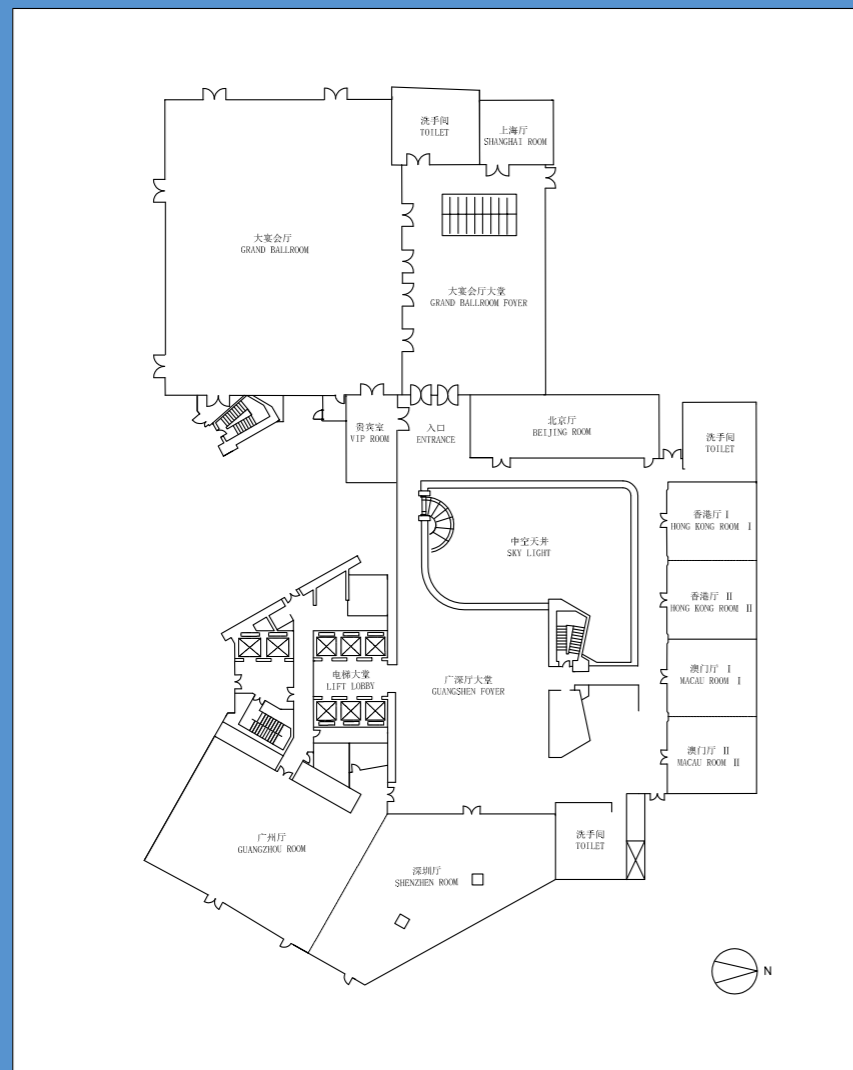

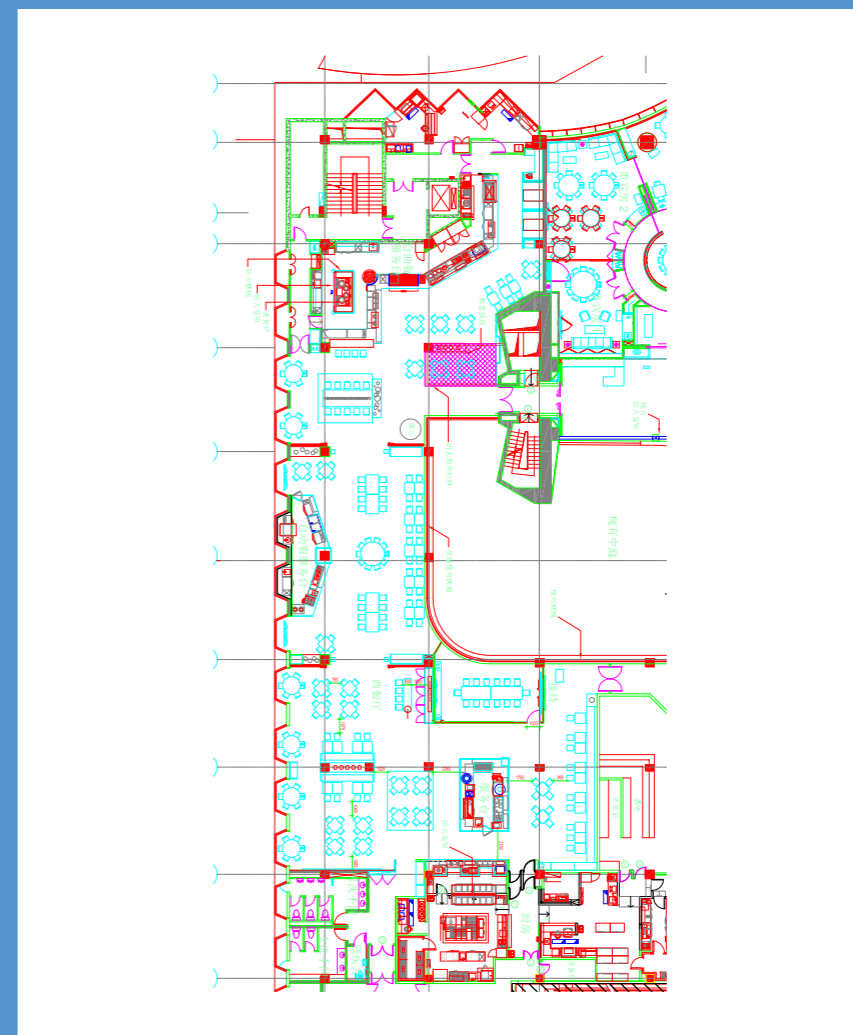


会场指示 Guide Map
